



### **Indorama Fertilizer, Polymers Excite** President Buhari at MAN Expo in Abuja!

... MD of Indorama Re-elected National Council Member of MAN







Mr. Manish Mundra, MD/CEO of Indorama, re-elected

ndorama's Urea fertilizer and its petrochemical products (polyethylene and polypropylene) were among made-in-Nigeria goods on display at a one-day exhibition organised by the Manufacturers Association of Nigeria (MAN) as part of its 44th Annual General Meeting (AGM) held at the Transcorp Hilton Abuja on Thursday, 29th September 2016.

President Muhammadu Buhari, who attended the AGM as Special Guest of Honour, also went round the exhibition stands, during which he expressed excitement over Indorama fertilizer, which currently serves the needs of over 20 million farmers across the country, and the petrochemicals (also called polymer resins), which are raw materials for over 450 companies in the plastics and allied industries.

The President was informed by the President of MAN, Dr Frank Udemba Jacobs that Indorama, which is based in

Port Harcourt is now producing fertilizers (1.5 million metric tons per annum) in addition to its petrochemicals. The President nodded excitedly and said he was quite impressed. He directed the ministers of Industry, Trade & Investment to follow up on the report.

President Buhari had in his speech at the AGM lauded the manufacturing sector as a major force in the nation's industrialisation drive, and pleaded with the operators to work hard

and collaborate with his administration to overcome the economic challenges facing the nation. The President acknowledged the difficulties being experienced by the operators in sourcing foreign exchange for their imported raw materials, and said the matter was being addressed.

It was the first time MAN was holding its AGM in Abuja and the first time a sitting President was attending the event.

The President attended the event with four of his ministers, namely Minister of Industries, Trade & Investment, Dr Okechukwu Enelamah; Minister of Solid Minerals, Dr Kayode Fayemi; Minister of the Federal Capital Territory, Malam Muhammad Musa Bello; Minister of State for Industry, Trade & Investment, Ms Aisha Abubakar as well as the Chairman, Senate Committee on Industry, Sen. Dr. Sam Egwu.

Indorama Group Nigeria and Dangote Group received prime exposure and commendation as the President of MAN Dr Frank Udemba Jacobs in his welcome address, announced the two companies as the major sponsors of the AGM. He enumerated various challenges facing manufacturing companies and pleaded with President Buhari to find solutions to them.

Alhaji Aliko Dangote was the guest speaker at the AGM, and spoke on different ways of restructuring the economy across various sectors of the economy in an effort to exit economic recession. According to him, restructuring should touch the entire agricultural value chain including food processing, as well as the oil and gas, solid minerals, power, infrastructure sectors, etc.

Mr Manish Mundra, Managing Director of Indorama Nigeria was reelected into the National Council of MAN. Indorama was also given an award for its contributions to MAN and which received by Dr Jossy Nkwocha, special adviser to the Managing Director. The award was presented by the Minister of Industry, Dr

Indorama's stand at the exhibition featured live bags and samples of its prime products -- polymer resins and Urea fertilizer, which attracted so many visitors. About 120 manufacturing companies exhibited their products at the event, which was seen by many as the best attended and organised in recent history.

## **Indorama-ICS Completes 20-MW Coal Based Power Plant in Senegal**

Indorama-ICS has made history by completing in record 15 months a 20-mega-Watts coal-based power plant in Senegal. This project guarantees good reliability in production and energy in Industries Chimiques du Senegal (ICS), in which Indorama acquired a majority stake in 2014. Group Chairman of Indorama Corporation, Mr. S. P. Lohia inaugurated the project.

ccording to reports, ICS was facing huge crises of steam and power for acid and rock phosphate production. Steam was generated in HFO boilers. These boilers were very old and highly unreliable and cost of steam generation was about USD 90 perton.

In fact, the mine had to be stopped every day for four hours due to power shortage from national grid, Senelec. In addition, Senelec power was tripping frequently and quality of power was also a major challenge for reliability of equipment.

Indorama management decided to install one power plant to make ICS self-sufficient in power and steam and even to supply excess power to Senelec grid.

Wuxi Guolian Huaguang Power Engineering Co. Ltd, China, was engaged as Engineering, Procurement, and Construction (EPC) contractor for the power plant consisting 2x75 TPH boilers, 1x20 MW turbine and other utilities. CSL, a local company, was engaged for civil works.

State-of-art-the technology Circulating fluidized bed (CFBC) coal fired boilers were selected. CFBC Technology operates on lower temperature with higher efficiency and minimum emissions compared to conventional boilers. Highly-efficient electrostatic precipitators with four fields were included in the project to comply with environment norms and regulations.

Ground breaking ceremony was done on 30th Jan 2015 and civil work started immediately. Erection activities started in last week of July 2015 and first boiler was commissioned on 19th May 2016. Second boiler start up and turbine synchronization was done on 17th June 2016.

# **INDORAMA**'s **IPACT**

Raw Materials for Industries \*Employment Generation

**Huge GDP/ Revenue for** Government

\*Community Development **Gains of Employees** 

he monumental impact of Indorama Eleme Petrochemicals Limited (IEPL) on the economy and people of Nigeria can best be summarized by quoting a recent submission by the Acting Director of the Bureau of Public Enterprises (BPE), Dr Vincent Onome Akpoaire, during the investigative hearing on the privatisation process and performance of Eleme Petrochemicals by the House of Representatives Committee on Privatisation.

Dr. Akpotaire stated that the sale of the almost moribund petrochemicals company in May 2006 represented the best success story of the Federal Government's privatisation programme in terms of compliance to the executed Share Purchase Agreement (SPA) and the Post Acquisition Plan (PAP) as well as contribution to the Gross Domestic Product (GDP) of Nigeria and the creation of huge employment opportunities in the country.

The Acting DG informed the Committee that Indorama-Nigeria has

completed construction of the world's largest single train Urea plant in Port Harcourt of 1.5 million metric tons capacity along with associated infrastructure with total investment of \$1.5 billion, and revealed that the Indorama Group plans to bring total investments in the company to \$4.2 billion by 2020.

He further stated that because of the impressive performance and compliance of

The Hon. Minister said the Federal Government relies so much on Indorama fertilizer to realize its goal of bumper harvest and food security in the country.

Indorama to all the obligations it covenanted in the PAP and SSPA signed with the federal government, the National Council of Privatisation (NCP) had at its meeting on December 18, 2014, approved the 'discharge' of the company from the 5year monitoring programme of BPE

Dr. Akpotaire added that within 10 years after take-over of the old Eleme Petro chemicals, it has

recorded many milestones in its vision of building Africa's largest petrochemicals and fertilizer hub in Nigeria as it now operates at over 100 per cent capacity, meeting the need of the Nigerian plastics industry, which utilizes petrochemical products (polymer resins) as its raw materials.

BPE, being the federal government agency that supervises the privatisation programme in Nigeria, is indeed the best to assess the performance of Indorama Eleme Petrochemicals in the past ten years.

Another FG agency that exercises oversight on IEPL is the Raw Materials Research & Development Council (RMRDC). In the past ten years, it has continued to monitor the activities of IEPL in helping to provide essential raw materials for industries in the country.

Dr. M. O. Omojola, Director (Industrial Chemicals and Minerals Department) of RMRDC who has led several industrial visits to IEPL says the company has revolutionized Nigeria's

industrial sector with various customized grades of ethylene, polyethylene, polypropylene, PET, preform and industrial sacks, which were all hitherto imported into the country at huge foreign exchange cost.

According to the website of RMRDC, Indorama is the live-wire of over 450 companies in the plastics, pharmaceuticals, foam, bottling, beverages, paints, breweries, etc

sectors, which it provides with raw materials. Before Indorama came on stream in 2006, Nigeria's plastics sector had shrunk terribly as a result of lack of raw materials or high cost of importing them.

But with Indorama providing the raw materials in a sustainable manner, the sectors have grown by over 300%. This explains the huge impact that Indorama operations have on the Gross Domestic Product (GDP) of Nigeria and employment generation across various sectors

In some instances, RMRDC has appealed to IEPL to go into local production of some categories of polymer resins that were imported. As a result of such call, Indorama built and commissioned a new plant to produce Poly-ethylene Terephthalate (PET), which is largely used in producing bottles for table water, aerated water, fruit juices, drugs, beers, beverages, etc. Indorama-Nigeria produces 86,000 metric tons of PET, which satisfies the entire domestic demand for PET, thereby saving Nigeria the high cost of importing the raw material.

According to Mr. Chirag Jesalpura, head of Marketing of IEPL, the journey of last 10 years was started with anxiety in the industry about a new start-up and "we struggled to give assurance of consistent quality products and uninterrupted supply."

ndeed, in 2006, IEPL faced huge challenge of trust building at those uncertain times when Nigeria was 100% import dependent for plastic raw materials. Industry was burdened to keep 5-6 months inventory, making it difficult for small entrepreneurs to enter and succeed in the sector.

The IEPL marketing team with support from the Company's Plastic Technology Development Centre (PTDC) technical know-how went round the country, explaining, convincing and delivering promises of world class

products at competitive prices. This involved multipronged strategy that facilitated banking channel, technical support, building logistic chain, distribution network, and continuous personal contacts with customers.

Gradually, as IEPL built confidence, the plastic industry and entrepreneurs were encouraged to bring new machines and industry started growing around 14%-15% Compound Annual Growth Rate (CAGR) from 2008-2009. There was inclusive growth of the plastic industry including Niger Delta, Eastern, Western regions and the Northern part of the country, driving employment generation and bringing down logistic cost of end products

In the first year, IEPL registered more than 250 customers, indicating enthusiasm of industry. Today the registered converters plastic (industry) stands more than 600, out of which more than 350 are active and regular converters patronize IEPL products. The sales have increased close to four fold from 80 KT to 320 KT in domestic market. New customers keep approaching IEPL every month, and we endeavor to service more and more

"At this milestone, we feel contended contributing to success of Nigeria's industry and adding value to country's growth in GDP. Surplus products were exported to earn foreign exchange for the country" he said.

n 2012, Indorama Eleme Petrochemicals won the Presidential Award for export of petrochemical products to about 20 countries across four continents, which proudly put Nigeria on the global petrochemicals export map. This award was organised by the Nigerian Export Promotions Council (NEPC)

But since then, RMRDC has prevailed on Indorama to draw down on its export operations so that the growing

Nigerian plastics sector can have enough. As a patriotic duty, Indorama has at this advice, and presently sells more than 99% of its products locally!

n the area of job creation, Indorama-Nigeria employs about 3,000 direct employees in Port Harcourt, Lagos, Abuja, Kaduna and Kano operations as well as over 4,700 indirect jobs. The International Finance Corporation (IFC) estimates 3 employment per ton of polymer in the plastic, hence as at 2015, Indorama and its Strategic Business Units (SBUs) have provided about 7,702 jobs.

A greater number of jobs are also created through the fertilizer value chain as Indorama supplies Urea across the country to Nigerian farmers. "Employment generation is strategic and very important in nation building. In the past ten years, our impact on employment in Nigeria is very huge," says Mr Pradeep Ekka, head of HR department.

Indorama has also made tremendous impact in its six host communities namely Akpajo, Njuru/ Akpakpan, Okerewa, Aleto, Agbonchia and Elelenwo, as well as other 34 pipeline communities. The company successfully signed and implemented three Memorandums of Understanding (MOUs) in 2007, 2011 and 2013, which provided overall framework of engagement between the company and the communities.

According to Kendrick Oluka, head of Community Relations & Development, Indorama's biggest impact in the six host communities is the allotment of 7.5% shares, which has put more than N14 billion in the hands of the people since 2012. This has greatly empowered the people financially to build houses, pay children's school fees, live the good life, among

Specific projects handled by the company

for the communities include building a Community Secondary School at Aleto community. The facilities include 12 classrooms, a library, laboratories, staff rooms, Principal's office, sick-bay, etc

Others include annual scholarship scheme for indigent indigenes of the host communities, pipeline communities and other areas of Eleme; renovation of Eleme General Hospital and donation of medical equipment worth over N80 million to the hospital; 33KVA Power sub-station at Akpajo to enhance rural electrification of the area and construction of Police station for Elelenwo.

Mr Oluka said the projects also include road projects for Agbonchia, Njuru and Okerewa communities; building of new 6-classroom block for Omoku community, one of the pipeline communities; building of new 6-classroom block for Uiu community, another of the pipeline communities as well as micro-credit scheme for women in the communities, which is meant for poverty alleviation and women empowerment, especially for the widows.

n July 2015, Indorama-Nigeria contributed N530 million to rehabilitate the Eleme-Onne Federal Highway which had become impassable. On November 24th 2016, the company made donation of solid high quality table-seats to the Nigerian Navy Basic Training School Onne, in Rivers State.

Indorama-Nigeria is indeed making its mark in CSR, which it regards as a worthy corporate social investment. Experts believe that Indorama's excellent relations with the host communities account to a large extent for the peaceful atmosphere that attends its operations and underlines its success story.

On 9" November, 2016, the Senate Committee on Privatisation &

Commercialisation visited Indorama-Nigeria as part of its routine oversight function. Mr Munish Jindal, CEO of Indorama Fertilizer, who stood in for the Managing Director of Indorama-Nigeria, Mr. Manish Mundra listed a myriad of socioeconomic benefits that the Company has bequeathed to Nigeria since it acquired the old Eleme Petrochemicals in 2016.

After Mr. Jindal's presentation and a tour of the plants, Chairman of the Senate Committee, Senator Ben Murray Bruce, said he was indeed convinced that Indorama Eleme Petrochemicals is the best success story of privatisation in the country.

"We have gone round to see most of the privatised enterprises; Indorama is the success story, especially in providing base raw materials for Nigerian industries and fertilizers for Nigerian farmers as well as paying huge tax revenue of over N1 billion to government in the past ten years, and developing your host communities," Sen. Bruce said.

Indorama has also paid huge dividends to both the federal government and the Rivers state government who own 15% and 10% shares respectively.

On Tuesday, 15th November, the Minister of State for Agriculture & Rural Development, Senator Heineken Lokpobiri visited the Indorama Complex in company of his top officials. His assessment of Indorama is that of excellent performance, especially in the area of providing fertilizers for farmers across the country.

The Minister of State said the Federal Government relies so much on Indorama fertilizer to realize its goal of bumper harvest and food security in the country. Managing Director of Indorama-Nigeria, Mr Manish Mundra assured the Minister that the company will continue to pursue its vision of making Nigeria the petrochemicals and fertilizer hub of Africa by the year 2020.

#### Indorama-ICS Completes Plant

Power plant is very well connected to supply steam and power to acid plant and mines and also to Senelec. Steam from this power plant is also being used to run one old 13 MW turbine in acid plant. Coal is being received from South Africa and from port it is delivered to plant by trucks and train.

The power plant was commissioned within 15 month without any lost time injury (LTI). The major milestones are as follows: (a) Ground breaking Ceremony – 30th Jan 2015 (b) Starting of Erection activities - 23rd July 2015 (c) Boiler Ist Hydro test - 9th Oct 2015 (d) Steam Supply from Boiler -1 - 19th May 2016 (e) Steam supply from Boiler -2 - 13th June 2016 (f) Turbine synchronization - 17th June 2016.

Start-up of power plant resulted in consistent supply of steam and power to acid plant and mine. There is no production stoppage due to non-availability of energy. Now ICS is a black-out free company as new power plant, acid plant and mine are very

Steam generated by coal is much cheaper compared to HFO boilers and there is a saving of energy cost of USD 60 per ton of phosphoric acid. Plant has given 30 MW power relief to Senegal which is a power deficit country.

Now ICS is self-sufficient in power and 8-10 MW power is being supplied to Senelec grid

In each of the plants, there were engineers who took them on the practical workings of the individual plant's operations. They includes: Engr.
